HELOC EARLY DISCLOSURE AND IMPORTANT TERMS OF LINE OF CREDIT PLAN

This disclosure contains important information about the **Security Service Federal Credit Union** home equity line of credit account. You should read it carefully and keep a copy for your records.

Availability of Terms. All of the terms below are subject to change. If any of the following terms change (other than the annual percentage rate), and you decide, as a result, not to enter into an agreement with us, you are entitled to a refund of any fees you paid us or anyone else in connection with your application.

Security Interest. We will take a security interest in your home. You could lose your home if you do not meet your obligations in your Home Equity Line of Credit Agreement.

Possible Actions. We can terminate your line of credit, require you to pay us the entire outstanding balance in one payment and charge you certain fees if:

- You engage in fraud or material misrepresentation in connection with the line of credit.
- You do not meet the repayment terms of the line of credit.
- Your action or inaction adversely affects the collateral (your home) or our rights in the collateral.

We can refuse to make additional extensions of credit (“advances”) or reduce your credit limit if:

- The value of the collateral securing the line is significantly below its appraised value for purposes of the line of credit.
- We reasonably believe that you will not be able to meet the repayment requirements of the line of credit due to a material change in your financial circumstances.
- You are in default of a material obligation in the agreement.
- Government action prevents us from imposing the annual percentage rate provided for in the agreement or impairs our security interest such that the value of the interest is less than 120% of your credit limit.
- A regulatory agency notifies us that continued advances would constitute an unsafe and unsound practice.
- The maximum annual percentage rate is reached.

The initial account agreement permits us to make certain changes to the terms of the agreement at specified times or upon the occurrence of specified events.

Minimum Payment. You can obtain advances for **15** years. This period is called the “draw period.” The “Minimum Monthly Draw Period Payment” is equal to the FINANCE CHARGES that have accrued on the outstanding principal balance during the preceding month with a Minimum Payment of \$10.00 or the principal balance if the Minimum Payment is less than \$10.00, together with all past due amounts, amounts in excess of your Credit Limit, late charges, insurance premiums and other fees imposed to the extent allowable by applicable law.

After the draw period ends, you will no longer be able to obtain advances and must pay the outstanding balance over **25** years (the “repayment period”). During the repayment period payments will be due monthly. Your minimum monthly payment will equal the balance outstanding at the end of the draw period fully amortized over 300 months.

Minimum Payment Example. If you took a single \$10,000 advance and the **ANNUAL PERCENTAGE RATE** were 5.00%, it would take 8.58 years to pay off the advance if you made only the minimum payment. During the draw period you would make 103 monthly payments varying between \$100.00 and \$150.00.

Fees and Charges. To open and maintain a line of credit, you must pay us the following fees:

Fees

No fees are charged to open and maintain a line of credit.

Other Charges

(a) **Late Charge.** If we do not receive your minimum payment within ten (10) days of its due date, we will charge you a late charge of 5.00% of the amount of the payment past due.

You also must pay certain fees to third parties to open a line of credit such as appraisers, title companies and government agencies. These fees generally total between \$250.00 and \$3,500.00. In addition, you must carry insurance on the property that secures the line of credit. If you ask, we will give you an itemization of the fees you will have to pay to third parties.

Negative Amortization. Negative amortization will not occur under this plan.

Finance Charge Accrual. The periodic interest finance charge begins to accrue on the date that a Loan Advance is made from your Account.

Minimum Advance Requirements. The minimum advance you may obtain is \$250.00.

Tax Deductibility. You should consult a tax advisor regarding the deductibility of interest and charges on your line of credit.

Variable Rate Information. This line of credit has a variable rate of interest. The annual percentage rate (corresponding to the periodic rate) and the minimum monthly payment can change as a result.

The annual percentage rate includes only interest and not other costs.

The annual percentage rate is based on the value of an index. The index is the highest "Prime Rate" as published in the "Money Rates" table of the online or print edition of The Wall Street Journal. To determine the annual percentage rate that will apply to your line, we add a margin ("Margin") to the value of the index. Ask us for the current index value, margin and annual percentage rate. The initial annual percentage rate is not based on the index and margin used to make later rate adjustments. The initial annual percentage rate will be in effect for the first twelve consecutive months following the month in which the plan is opened. After you open a line of credit, rate information will be provided in monthly billing statements that are sent to you.

Rate Changes. The annual percentage rate can change quarterly. The maximum **ANNUAL PERCENTAGE RATE** that can apply is 18.00% or the maximum permitted by law, whichever is less. However, under no circumstances will your **ANNUAL PERCENTAGE RATE** go below 2.99% at any time during the term of the plan.

Maximum Rate and Payment Example. If you had an outstanding balance of \$10,000 during the draw period, the minimum monthly payment at the maximum **ANNUAL PERCENTAGE RATE** of 18.00% would be \$152.88. If you had an outstanding balance of \$10,000 during the repayment period, the minimum monthly payment at the maximum **ANNUAL PERCENTAGE RATE** of 18.00% would be \$151.74. This annual percentage rate could be reached in 3 months.

Historical Example. The following table shows how the annual percentage rate and the monthly payments for a single \$10,000 advance would have changed based on changes in the Index over the past 15 years. The Index values are from the first business day of June, of each year. While only one payment amount per year is shown, payments would have varied during each year.

The table assumes that no additional advances were taken, that only the minimum payment was made each month, and that the rate remained constant during each year. It does not necessarily indicate how the Index or your payments will change in the future.
